Fees for re-examination viz. (i) Rs. 60.00 per paper, (ii) Cost of Form Rs. 25.00, (iii) Cost of result preparation Rs. 15.00 etc. once paid , will not be refunded under any circumstances.

It is noted that the Re-Examination of answer scripts in theory papers only excluding any practical paper or internal assessment or project work / field work, may be done in accordance with the following procedure :

In terms of clause 7 (iv) of the said Regulation, a candidate of Honours course appearing in Part II examination will have the option for getting his/her answer scripts re-examined in any one Honours paper or one General paper provided he/she secures 40% marks in aggregate of Honours / General excluding the Honours / General Papers for which re-examination is sought.

In terms of clause 7 (i) of the said Regulation, a candidate of General course appearing Part II examination will have the option for getting his/her answer scripts re-examined in any one General paper only provided he/she secures 40% marks in aggregate excluding the papers for which re-examination is sought.

The office of the colleges are requested to submit the aforesaid applications maintaining the serial of category-wise / Roll No –wise with a statement to the office of the controller of Examinations positively on **15.11.2018**.


